ORDINANCE AUTHORIZING DESIGN-BUILD

WHEREAS, the State of Mississippi authorizes the Mississippi Transportation Commission (the "Commission") in Section 65-1-85(11) of the Mississippi Code Annotated to bid projects on the Design-Build Method.

WHEREAS, the "Design-Build" method of contracting according to Section 65-1-85 11(b) means "a contract that combines the design and construction phases of a project into a single contract and the contractor is required to satisfactorily perform, at a minimum, both the design and construction of the project.

WHEREAS, the Commission is required to establish "detailed criteria for the selection of the successful design-build contractor in each request for design-build proposals. The evaluation of the selection committee is a public record and shall be maintained for a minimum of ten (10) years after project completion.

WHEREAS, the Commission was required to submit to the Legislature "evaluating the design-build method of contracting by comparing it to the low-bid method of contracting.

WHEREAS, based upon the evaluation by the Legislature, the design-build method was allowed to expand apparently indicating significant savings from the low-bid method.
